ORDER:

- Narasaraopeta Institute of Pharmaceutical Sciences, Yellamanda, Narasaraopet, Guntur, Andhra Pradesh has applied for Permanent Affiliation during 2022-2023 and Committee has been constituted to physically verify all the requirements as per FFC template. The Committee has submitted its report vide ref (1) cited and Scrutiny Committee has recommended Permanent Affiliation for three years ie.2022-2023 to 2024-2025.
